Dear Commissioner Hogan,

Firstly, we would like to thank you for your personal effort made so far, however Baltic agriculture sector and product markets are still suffering serious consequences of the ongoing Russian embargo, the higher yield export market loss, and the turbulence on the global markets.

Taking into account that the price decrease has not stopped and, according to estimates, is to continue, losses borne by Baltic producers are building up. Therefore, despite the EU exceptional temporary aid and the national aid, estimated total amount of **still uncompensated** losses in Baltic agriculture:

- Latvia (estimated for the period from August 2014 to August 2016): dairy sector uncompensated losses 96 million EUR and losses in pigmeat sector 24 million EUR.
- Lithuania (estimated for the period from August 2014 to August 2016): uncompensated losses in **dairy sector** are **223 million** EUR, losses in pigmeat sector **25 million EUR**
- Estonia (estimated for the period from August 2014 to August 2016): losses of dairy **67 million EUR**, losses of pigmeat sector **15 million EUR**.

Therefore we call for EU measures of immediate action:

- Further exceptional temporary targeted directed support measures in order to prevent a wave of bankruptcy of agriculture producers in Baltics.
- Promotion of cooperation between farmers (for example, enhance own processing and distribution of final products in existing cooperatives).
- Increase ceiling of *de minimis*.
- Provide effective means of financing and refinancing existing loans, in order to further rebalance cash flows of individual farmers and cooperatives, and a possibility to use leasing facilities in reasonable manner, abolishing the bureaucratic obstacles within the rural development program and others.
- Improvements of market intervention mechanism.
- Creation of EU-wide instruments for export credits.
- Support for acquiring new export markets and revision of promotion programs.
- Reduction of agricultural production costs (e.g. agricultural equipment and plant protection product prices; cancellation of import duties for fertilizers, etc.).

In addition we ask for a long term EU strategy to better overcome and mitigate market crisis, considering compensation of losses and possible means of balanced management of oversupply, for at least two upcoming years.

We invite the European Commission to find best solutions for farmers to overcome market crisis, especially for farmers of the Baltic States. We are looking forward for fruitful cooperation and best solutions for farmers.
